This NKH is owned and operated by **NAL Academy Limited** ("NAL", "we", "our", or "us"), a company incorporated under the Companies Act, 2013, having its registered office at 202, Ashok Compound, Lal Bahadur Shastri Marg, Ghatkopar West, Mumbai, Maharashtra – 400086.
